The 26th Annual Business Meeting of the Fuller Society was held at the Otesaga Resort Hotel in Cooperstown, NY on 13 Oct 2018.

Governor Deb Yingst welcomed everyone and Bill Wenzel gave the opening prayer.

Governor Yingst stated that it has been a great year for The Fuller Society and looks forward to continuing the partnership with the General Society of Mayflower Descendants as the Board of Assistants voted to donate \$250 to the GSMD and be advertised on their website. The BOA also voted to donate \$125 to The Samuel Fuller School, and \$125 to Plimoth Plantation. A motion was made by Skip Hottinger to accept the donations, Ellie Lienau seconded. Motion passed. Governor Deb read an invitation from Harlston England encouraging Fuller descendants to come and visit and participate in the commemoration of the anniversary in 2020 and stated that the 2019 Annual meeting will be held in Philadelphia, PA.

Minutes: A motion was made by Ralph Miller and seconded by Skip Hottinger to dispense with the reading of the minutes of the 25th Annual Meeting Hyannis Port, MA. Motion passed.

Secretary's Report: Linda Hoffman reported there are a total of 255 members consisting of 175 regular and 81 life and that as of 8 Sep 2017 there have been 45 new members and 10 reinstated. She also noted that 35 members were dropped in 2018.

Treasurer Report: Marcia Shaw presented the Treasurer's report which shows the total equity for the Society is \$27,392.17 and stated the Society is doing well financially. Skip Hottinger made a motion to accept the Treasurer's Report. Ralph Miller seconded.

Junior Chair Report: Roxy Pemrick reported that the Society has a total of 52 Juniors as of 13 October 2018 encourages all eligible Juniors to apply for the Scholarship in 2019.

Scholarship Chair Report: Kim Skellie submitted her report on the 2018 Scholarship and thanked the committee for work in selecting a winner for the 2018 Scholarship. First place was awarded to Kate Peddicord and second place was awarded to Melanie Fuller.

A motion was made by John Yingst and seconded by Marilyn Hottinger to adjourn. Meeting adjourned.

Proposed By-Law Changes

Article II. Section 2—current: To encourage research and publication of the Pilgrim lineage beyond that of the Mayflower Five Generations Book. Initiating professional research and documentation of the Pilgrims and to publish all findings in suitable form.

Change: To encourage research and publication of the Pilgrim lineages beyond that of the Mayflower Families Silver Books.

Article III. Section 2b—current: Membership in this Society requires a written application and an application fee of \$10.00 (\$5.00 between July 1st and December 31st), which is sent to the Treasurer of the Society.

Change: Membership in this Society requires an application which is sent to the Treasurer or Secretary of the Society and an application fee of \$10.00 (\$5.00 between July 1st and December 31st), which is sent to the Treasurer or Secretary of the Society or paid via electronic methods through the Society website.

Article III. Section 5a— add "or Secretary" to Members failing to pay dues for the current fiscal year shall be notified by the Treasurer. Add: Inactive members whose dues are in arrears shall be reinstated in a subsequent year upon payment of the current year's dues and one year's past dues.

Section 5b—current: A regular member in good standing may resign membership by writing a letter of resignation to the Treasurer.

Change: A regular member in good standing may resign membership by written notification to the Treasurer or Secretary.

Article V. Section 1b—current: Appoint all committee secretaries and chairman, and be an ex-officio member of all committees **Change:** Appoint all committee chairs, and be an ex-officio member of all committees.

Section 1g - current: Assist the Newsletter editor in the preparation for printing of the newsletter in March, July and November.

Change: strike "for printing" and add "for distribution".

Add Section 1h: Complete the Annual Report filing for the Charter of the Society as required.

Section 3—delete "Corresponding/Recording" preceding "Secretary" and all other occurrences within the document.

Section 4a. Delete: Send notices of dues.

4d current: Maintain a general treasury account meeting the needs of the budget and an interest bearing account for the deposit of Life memberships, gifts and bequests; these accounts will be named "The Fuller Society", and bear the names of the Treasurer, Governor and one Assistant.

Change: delete "and one Assistant".

Add 4g. Complete yearly required tax filing as required by the IRS.

Article VIII. Section 1—current: An Auditing Committee composed of at least two member of the Society shall audit the Treasurer's accounts and report to the annual meeting.

Change: An Auditing Committee appointed by the Governor shall audit the Treasurer's accounts and report to the annual meeting.

Section 2—delete: An England Research Committee shall investigate and research into the pre-1620 life and ancestry of the Mayflower Pilgrims.

Article IX—current: Amendments to the By-Laws may be made at any Annual Meeting by a majority vote, provided that the notice of such amendments is given in the announcement for the Annual Meeting.

Change: Amendments to the By-Laws, as approved by the Board of Assistants, may be made at any Annual Meeting by a majority vote.

These changes are recommended by the Board of Assistants. Voting on the changes to the By-Laws will take place at the 2019 Annual Meeting to be held in Philadelphia, PA.


